Re: 2025-26 Seasonal Court Renewals



Dear Captain,

The word that comes to mind in preparing for our 55<sup>th</sup> Seasonal Renewal is **calm**! In a complicated and often chaotic world, that we are all trying our best to navigate, we promise to continue to offer a place of *calm*, focusing on fitness and relationships. Leave your stress at the front door and escape with us in a safe and hospitable environment. Every day we have the privilege and opportunity to change people's lives and help improve one's physical, social and mental health through tennis. Now that's something we can all be excited about!

With that being said, all the information your group needs to complete the renewal process for 2025-26 follows this letter and is also on our website [www.yonkerstennis.com](http://www.yonkerstennis.com). Kindly forward the information to your fellow players as only the captain receives this email.

A few things to keep in mind...

- **The renewal period is TWO weeks from 2/1-2/14.** Since most players wait until the last week anyway, this will help us simplify the process and accommodate change requests in a timely manner.
- As always, priority renewals are for existing courts so please lock in your court by the deadline date. New court requests and changes will be **waitlisted** and taken care of on a first come, first serve basis.
- **Deadline: February 14, 2025**
- Please be sure to read and understand the policies on the player payment/contract form you are signing, including but not limited to makeups and non-refundable court fees **after May 1<sup>st</sup>**.
- For your convenience, we continue to take payments from **individual** players (vs captain only) and offer the very popular 5% PIF discount if the *entire group* pays in full by **February 14, 2025**. As always, cash and checks are accepted as well.
- We also continue to offer an **installment plan**: 4 equal installments consisting of a 25% deposit then automatic deductions from your valid credit card on file on 10/1, 11/1 and 12/1.  
\***A minor change this year** to minimize some fees: a one-time annual administrative fee of \$20 applied to your 1<sup>st</sup> installment on 10/1, if you are enrolled in our Auto-Pay program (including multi-programs, Jr./Adult clinics and all players linked in billing for installments).
- You'll notice once again we have made calculating your cost easier by listing each time slot by the hour. You'll also find a second-rate sheet which combines the court and coach rate for Seapro courts, so you don't have to do the work 😊
- Our season will begin on **Monday, September 15<sup>th</sup>**, continuing with a 30-week season which allows for longer outdoor play.

## 2025-2026 Seasonal/Seapro Court Information Renewal Period 2/1-2/14, **DEADLINE 2/14/25**



In order to simplify the renewal process and accommodate change requests in a timely manner, the renewal period is two weeks this season, 2/1-2/14, **deadline 2/14/25**.

### How to Register:

- **Step 1: Choose a Group Payment option:**  
Decide which payment option works best for your "group", **Pay in Full** or **Auto-Pay program**.
- **Step 2: Submit a Court Captain Form:**  
The Captain is required to submit a Court Captain Form complete with roster and fee breakdown by player **prior to making any payments**.  
**Easy rate sheet: Seasonal (Court only) and Seapro (Court & Pro combined) per hour by time slot.**
- **Step 3: Player Payment/Contract:**  
All players are required to submit a Player Payment/Contract.

### Payment Options for Your Seasonal/Seapro Group Court:

Yonkers Tennis will accept payments from individual group members **only if organized by the captain and submitted prior with the roster and fee breakdown by player**.

- There are two payment options for you and your **GROUP: the deposit or full payment, due by 2/14/25**
  - 1. OPTION 1: PAY IN FULL: You and your group can pay in full.**
  - 2. OPTION 2: AUTO-PAY PROGRAM: You and your group can enroll in our Auto-Pay Program**  
If your group is enrolling in the Auto-Pay Program your fee will be divided into **4** equal installments, 25% deposit upon confirmation, the remaining balance will be taken in 3 equal monthly auto-pay installments on 10/1, 11/1 and 12/1. **The Auto-Pay Program is an additional \$20 fee which will be applied to the 1<sup>st</sup> installment on 10/1. This administrative annual Auto-Pay Program fee is a one time charge which includes multi programs and family members linked to your billing.**  
**You must have a valid form of payment on file, Amex, Discover, Visa or Master Card to enroll in our Auto-Pay plan.**
- All players must submit a signed/completed Player Payment/Contract to the front desk, convenient Drop Off Box located at the front desk counter or you can scan your form to [mlcummings@yonkerstennis.com](mailto:mlcummings@yonkerstennis.com). Your deposit or full payment will be processed upon confirmation through our back office to avoid overcrowding at the front desk.

**Pre-Paid Ball Program for Seasonal Courts only:** As a service to our customers, we offer premium grade tennis balls.

- If interested, please check the option on the Court Captain Form.
- The cost of the ball program is \$200.00, **PIF discount does not apply to the Ball Plan fee.**

### Emails:

- We **NEED** everyone's e-mail. This will help us communicate better with your court members regarding emergency notifications, snow cancellations, e-newsletters, specials and important dates. Privacy is important to us; therefore, we will not sell, rent, or give your name or address to anyone. Please update your email address during the year if it should change. At any point, you can click the link at the bottom of our e-mails to opt out.

## Seasonal/Seapro Court Group Agreement

- **Cancellations & Refunds:** You and your group may cancel this contract without further obligation and for a full refund within three days from the date of registration.
  - From three days after registration through **May 1<sup>st</sup>**, cancelled courts will be refunded **except** for the **non-refundable deposit**.
  - **After May 1, 2025 the entire court fee is non-refundable for cancelled courts unless resold for the season.**
- **The club does not rent a "specific" court.** The club rents only the day and time on any available court. Courts may be reassigned at any time at the discretion of the management.
- Courts may only use the facilities' teaching staff. **No outside teaching professionals are allowed to teach or use the facilities' teaching equipment.**
- The group will be responsible for any applicable federal, state, or local taxes that might be levied against these fees during the course of the season. This responsibility will not be waived even if the taxes are levied retroactively. Fees currently collected do not include any such taxes.
- No rebate, credit or makeup time shall be due for loss of group's reserved court time due to circumstances beyond the control for Yonkers Tennis Center, such as acts of God, strikes, etc.
- Court time unused by the playing **group** because of personal reasons or holidays cannot be made up. However, in the event your **group** is unable to use your court time and wish to resell it, you must notify the club in writing. If any portion of the court is resold you will receive a makeup. As a courtesy, a **maximum of three dates are allowed per season** and all makeups must be taken before the last day of the season. The captain is responsible to check if the court was sold.
- Management reserves the right to provide instruction on adjacent courts.
- Management reserves the right to change all or part of this offering without prior notice.
- The use of the center is strictly at the player's risk. The center is not responsible for injuries, accidents or damage to any person or to personal property arising from normal athletic activities in the premises. All groups and their guests hereby waive any claims for damages arising from their use of center facilities.
- All players must have a liability waiver on file prior to participating.
